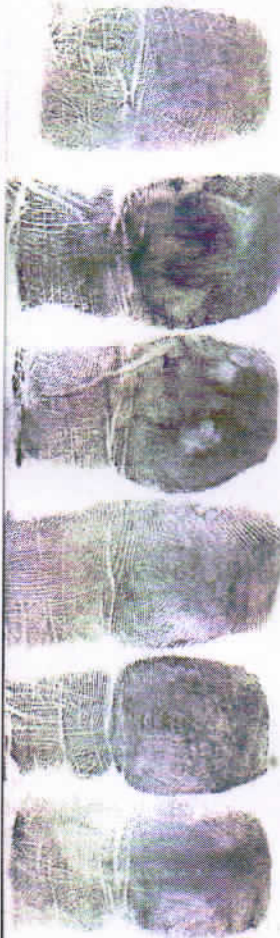





- 4) The custody and possession of all the Trust property shall vest with the Board of Trustees. The Management of the affairs of the Trust including the entire control, Supervision and the direction of the activities of the institution of Trust shall completely vest with Founder Trustee Chairman.

7) POWERS AND DUTIES OF BOARD OF TRUSTEES.

- (e) To receive grants and contributions either in kind or in cash from Central / State Governments, Local Bodies, Public Institutions such as Companies, Firms Individuals, N R Is and other countries for the object of the Trust.

- (c) The Founder Trustee Chairman by common consent of remaining Trustee may co-opt to the Board of the Trustees one or more but strength of the Board shall not at no time exceeds Fifteen. Such co-opt Trustees shall hold the office for such period as determined.
- (d) In case any vacancy caused by Resignation, Death or otherwise in the office of the Trustees shall be filled up by the Founder Trustee Chairman.
- (e) In the event of the Trustees failing or becoming incapacitated to act or discharge his duties continuously for a period of two years or any of the Trustee act against the interest of the Trust, the Founder Trustee Chairman shall have the power to remove him / her and appoint another person of his choice.

- (h) Three days notice or of such shorter period as the Founder Trustee Chairman deem proper depending upon the urgency of the subject to be discussed in the meeting shall be sufficient.


